The State IT Department proposes to setup a unit of Software Technology Parks of India (STPI) in Kangra district for which a piece of land near Gaggal Airport has been identified. The STPI would setup incubation facilities on the proposed land to help small start-up IT companies to setup their businesses with minimal capital expenditure. However, a part of land is under Forest and hence FCA clearance is required to be obtained before proceeding further in the matter. - The engagement of Consultant will be for seeking FCA clearance for setting up of STPI Unit in Kangra and may be extended to other Project of similar nature subject to the performance of the Consultant and the need.
- The Consultant would be responsible for preparing the FCA case, submitting it online and liaison with various agencies of State Government as well as Government of India, addressing the queries of various approving agencies, attending the meetings as and when required and finally got the FCA clearance done from approving agency.
- Interested Candidates are required to deposit their C.V. (giving full details of Name, Date of Birth, Father's name, Permanent address & Address for correspondence, Working Experience in dealing the FCA cases etc.
- Preference would be given to Bonafide Himachali candidates.
- There is no age bar but the candidates should be physically fit to undertake the field work.
- In case the performance of the Consultant is found un-satisfactory, his/her services can be terminated at any time without giving any prior notice.
- Selected candidates would have to sign an agreement with Society for promotion of IT and e-Governance (SITEG), on a Memorandum of Understanding (MOU) with duties and responsibilities.
- The selected candidate concerned may leave the contract by giving one month notice or depositing one month emoluments.
