e-Governance

IT happens in HP because we have...

- Been ranked among top 2 in India Today 'State of the States' Survey in Education, Health, Growth, Basic Infrastructure, Investment Environment, Budget and Prosperity, Consumer Market
- Comfortable climatic conditions and salubrious environs – far from the madding crowd.
- Time bound clearances (WeP in 3 months and Lenovo in 1 month from the date of site finalization!)
- Almost nil job attrition rate – We love our land and so will you!
- Un-interrupted, cheap and good quality power supply.
- More than 10,000 Km out of 13,500 Km (74%) metalled road has n x 2 mps OFC N/W, which is the maximum among all States.
- Tele-Density of 26.20% & 94.13% is the highest in the rural & urban areas (barring Delhi) respectively, in the country.
- Good quality of life, top class schools / colleges and peaceful law and order situation. **Extremely low extent of unionisation.**
- Excellent and extensive road infrastructure (zip from Shimla to proposed IT Park in 30 minutes flat!) and good accessibility (ATR at Shimla, Bhuntar and Dharmshala airports)
- Low capital & recurring costs (rental @ Rs. 10 per sqft right in the heart of Shimla town and no air-conditioning required)
- A vast pool of talented professionals for SMEs doing BPO and ITES operations available at reasonable emoluments
- The NIT, JPUIT, Polytechnics, HPU and other engineering institutes churn out more than 6500 professionals every year fit for the software industry (besides PEC, TIET and other engineering colleges in neighboring States)
- Entire database of Employment Exchanges on Job Portal
- Excellent English speaking skills – accent neutralization not needed
- STPI, Railtel, Power Grid Corporation, Airtel, Reliance and BSNL are various options for Internet Connectivity and dedicated B/Width.

This is why NASSCOM rated Himachal very high on 9 out of 13 parameters in its country wide survey. The projected annual turnover is Rs. 5000 crores by 31.03.12 from software and services.

Our Main Partners in Growth so far...

- Contrary to common perception, Himachal is now an industrial giant. An investment of US\$ 5 billion (Rs. 20000 crores plus) is being done only by 6679 industries registered since the announcement of Special Package.
- Some major players already in HP: Cadbury, TVS Motors, Wipro, P&G, Torrent, Ranbaxy, Hindustan Lever, Wockhardt, Bajaj, Lee Cooper, Johnson & Johnson, Pedders & Lloyd, Colgate Palmolive
- **Hardware:** WeP Peripherals, Microtek, Lenovo, Tritonics, TVSE, Samtel, Sukam, Luminous, eSys, SIS, Lipi Data Systems, LG, HFCL (Communications Equipment), Kaynes Technology, Numeric UPS etc.
- **Software and Services:** Hewlett & Packard (SWAN), Instablogs, Altruist Technologies, Cellerum, NIIT-GIS, Digital Vision (UK) etc.

Incentives Galore (cost savings ranging from 6 to 12%)...

- IT based units have been given the status of thrust industry
- **Central Excise Duty exemption** for 10 years from the date of commencement of commercial production (for units coming in production by 31.03.2010) on hardware and packaged software.
- **Income tax holiday** for five years and 30% rebate thereafter even for domestic operations and DGFT registered units. All software and service units (including training institutes) given status of industry.
- There is **no Central Sales Tax (CST)** for the new IT industrial units till March 31, 2013, for inter State transactions against Form C. **Rate of Sales Tax for institutional sales on production of Form CC (as notified by the Government of Himachal Pradesh) by the end customer is 1% without any outer time limit.**
- **Complete tax holiday (both VAT and CST) for 10 years at places as close as 70 kms. from Chandigarh.**
- **Input Tax Credit (ITC) for any kind of Inter State or Intra State sales (other than by consignment transfer).**
- **Capital investment subsidy @ 15%** for investment in plant & machinery, subject to a ceiling of Rs. 30 lakh, in the entire state of Himachal Pradesh without any area restrictions.
- The State Government can offer customized package of incentives for prestigious investment proposals i.e. projects where total investments are more than Rs. 10 Crore or a Fortune 500 company is implementing the project.
- Electricity Duty at the concessional rate of 10 paise per unit for a period of 10 years for units with a connected load exceeding 100kw from the date of start of production.
- **No Entry Tax/Octroi** in Himachal Pradesh for raw material/finished goods including related to IT industries.
- General permission is accorded to run a **three-shift operation**. Permission for **24x7 operation** is also granted.
- There is no restriction on employing women workers at late hours.
- **Industry friendly Labour Laws: No notification under section 10 of the Contract Labour Act**
- IT Industries have been declared as "Public Utility Service".

Way Ahead...

- **Integrated IT Township being set up at Waknaghat (23 kms. from Shimla) on land measuring 65 acres.** 10 major companies have given positive response to EOI. Work will start soon after selection of private partner through bidding process
- IT habitats at Solan, Hamirpur, Baddi, Parwanu, Kullu, Mandi and Dharmshala.
- Two knowledge corridors in the state: Pathankot-Jogindernagar and Parawanoo-Shimla
- ICD in Ludhiana and soon in Baddi
- Earmarked land for IT industries
